### Rally in Support of Wisconsin Public Employees

By now you must be aware of the push by the governor of Wisconsin to abolish the collective bargaining rights for public employees in Wisconsin. This action is nothing more than "union-busting" at the legislative level. We all need to stand strong with our Union Brothers and Sisters to protect the collective bargaining rights we have! If this is allowed to pass, corporations will not stop until they have the same laws in the private sector---**destroying unions and severely weakening all workers!**
